

ARTICLES OF ORGANIZATION
OF
ANYTHING AUDIO & VIDEO, L.L.C.

The undersigned, who intend to form and create a Limited Liability Company, under Title 10, Chapter 12 of the Code of Alabama (1975), as amended (the "Alabama Limited Liability Company Act"), hereby file the following Articles of Organization with the Probate Judge of Shelby County, Alabama, and affirm that the facts stated in these Articles of Organization are true and correct:

ARTICLE I.
NAME OF LIMITED LIABILITY COMPANY

The name of the Limited Liability Company shall be: ANYTHING AUDIO & VIDEO, L.L.C., (the "Company").

ARTICLE II.
REGISTERED OFFICE AND AGENT
FOR SERVICE OF PROCESS

The registered office of the Company is located at City of Pelham, State of Alabama. Its registered agent for service of process at the foregoing address shall be:

ARTICLE III.
PURPOSE OF COMPANY

The purpose for which the Company is formed is to be a business of audio and video equipment installation, sales and related services. Additionally, to engage in any lawful acts or activities for which limited liability companies may be formed under Section 10-12-3 of the laws of the State of Alabama.

ARTICLE IV.
DURATION OF COMPANY

The period of duration of the Company shall be from the date of the filing of these Articles of Organization with the Office of the Probate Judge for Shelby County, Alabama, until the first to occur of the following:

1. Fifty (50) years from the date of filing of these Articles of Organization, or



2. Dissolution of the Company pursuant to the laws of the State of Alabama or the Operating Agreement of the Company, as in effect from time to time.

ARTICLE V. INITIAL MEMBERS

ARTICLE VI. ADDITIONAL MEMBERS

Additional members may be admitted only upon the unanimous written consent of the then existing members and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted.

ARTICLE VII. CONTINUITY OF BUSINESS

Upon the death, retirement, resignation, expulsion, bankruptcy, dissolution, or dissociation of a member, or the occurrence of any other event which terminates the continued membership of a member in the Company, the business of the Company shall not be continued and the Company shall be dissolved unless there is obtained the written consent of all the remaining members of the Company within 90 days after the occurrence of the terminating event.

ARTICLE VIII. MANAGEMENT

The Company shall be managed by its managers. The names and mailing addresses of the managers who are to serve as managers until the first annual meeting of the members or until their successors are duly elected and qualified are as follows:

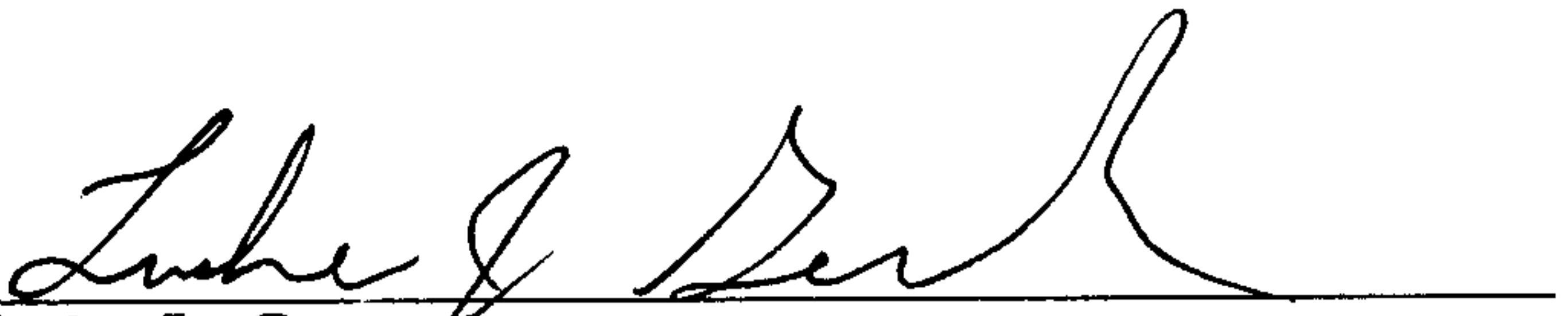
