

ARTICLES OF ORGANIZATION OF MC ENVIRONMENTAL SERVICES, L.L.C.

Pursuant to the Provisions of Act No. 93-724 of the 1993 Alabama Legislature or the Alabama Limited Liability Company Act, the undersigned hereby adopt the following Limited Liability Articles of Organization:

ARTICLE I

Name

The period of duration for the company is perpetual, beginning on the date these Articles of Organization are filed by the Probate Judge of Shelby County.

Purpose


The Company has been organized for the purpose of providing contract labor to clear railroad tracks of coal and debris and to clean railroad cars and running stock.

Ownership


