

**ARTICLES OF ORGANIZATION
OF
MC ENVIRONMENTAL SERVICES, L.L.C.**

Pursuant to the Provisions of Act No. 93-724 of the 1993 Alabama Legislature or the Alabama Limited Liability Company Act, the undersigned hereby adopt the following Limited Liability Articles of Organization:

ARTICLE I

Name

The name of the limited liability company is MC ENVIRONMENTAL SERVICES, Limited Liability Company or L.L.C.

ARTICLE II

Duration

The period of duration for the company is perpetual, beginning on the date these Articles of Organization are filed by the Probate Judge of Shelby County.

ARTICLE III

Purpose

The Company has been organized for the purpose of providing contract labor to clear railroad tracks of coal and debris and to clean railroad cars and running stock.

ARTICLE IV

Registered Agent and Office

ARTICLE VI

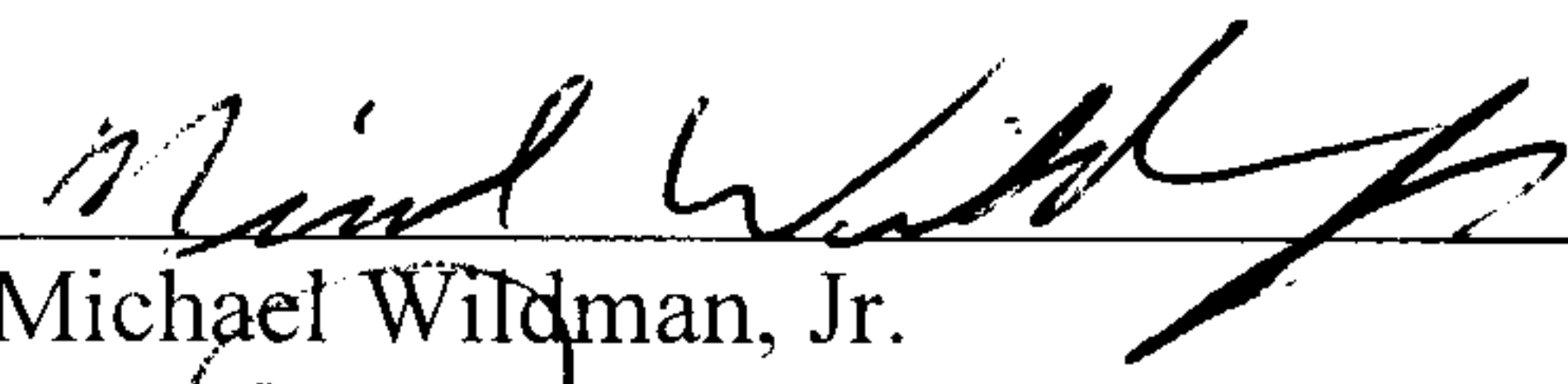
The remaining members of the Company shall have the right to continue the business after an event of dissociation terminates the continued membership of a member in the company on the unanimous consent of the remaining members.

ARTICLE VII

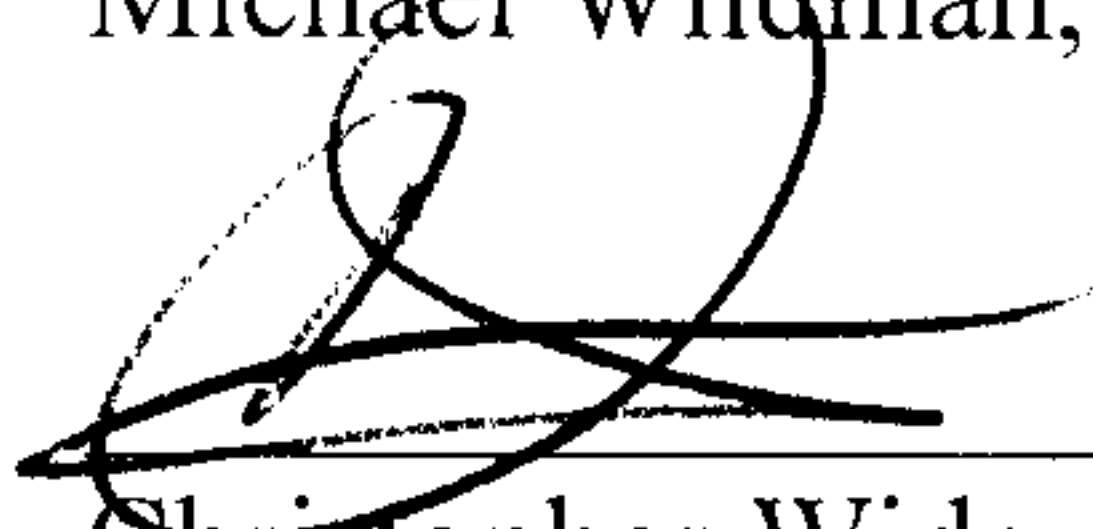
Ownership

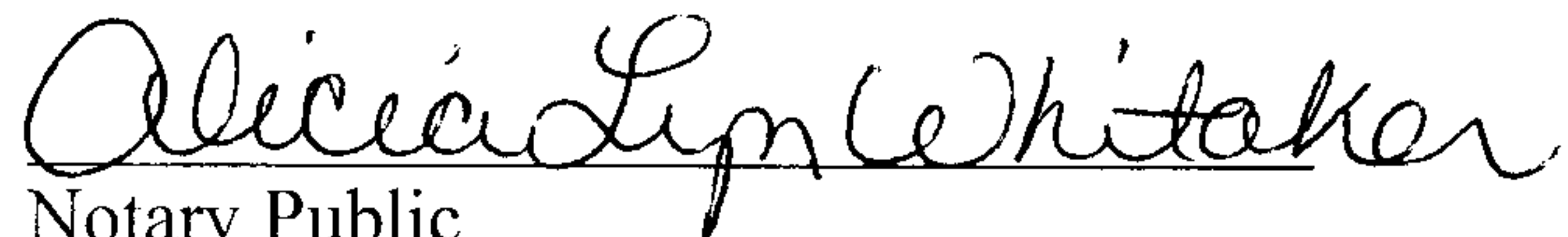
