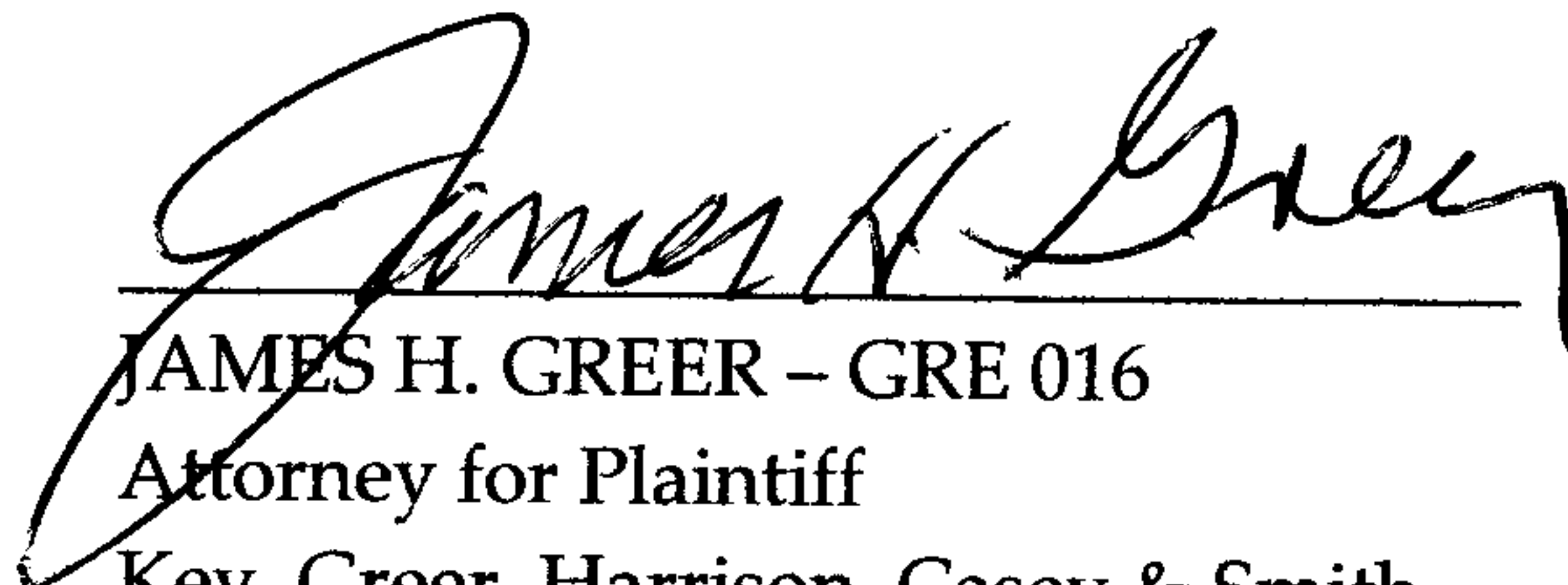

Highway No. 70; thence run along north right-of-way North 85°34'02" East for 174.92 feet to the point of beginning.
