KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 28th day of July, 2005, Christopher P. Key and Mary Katherine Key, husband and wife, executed that certain mortgage on real property hereinafter described to First Federal Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20050809000405810, said mortgage having subsequently been transferred and assigned to ABN AMRO Mortgage Group, Inc., by instrument recorded in 20070409000160170, in the aforesaid Probate Office ("Transferee"); and

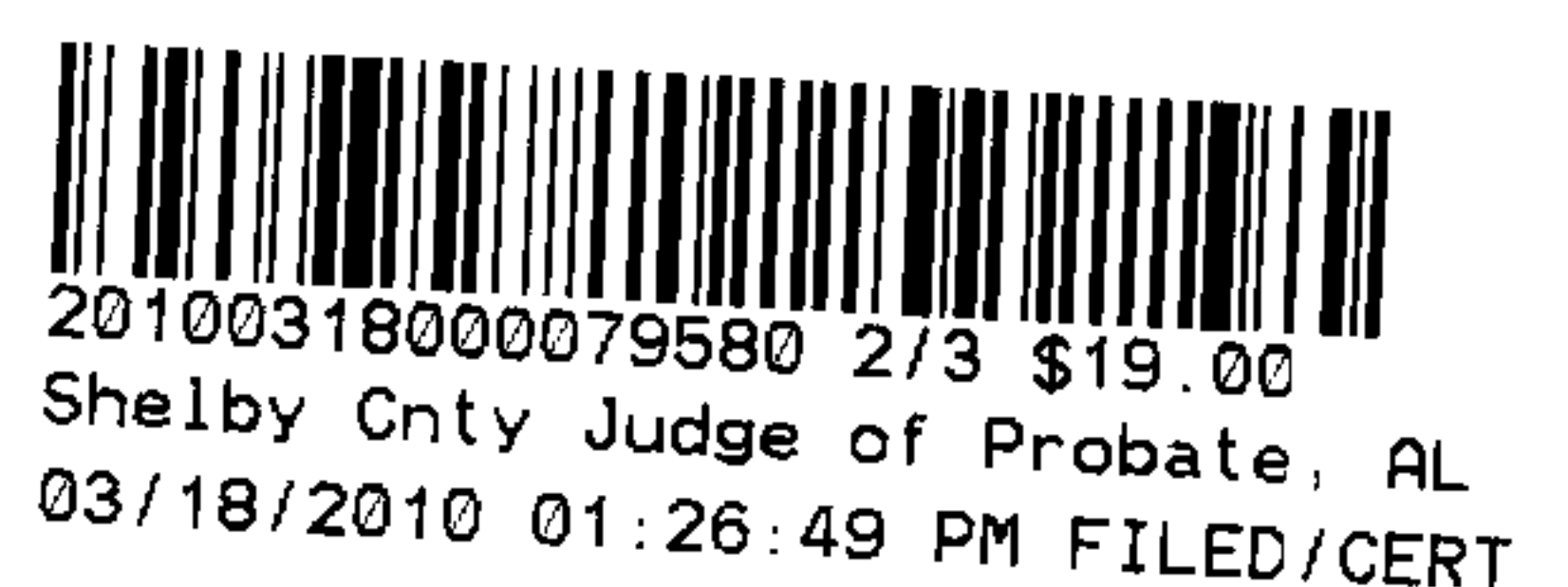
