KNOW ALL MEN BY THESE PRESENTS

THAT, WHEREAS, heretofore, on to-wit December 31, 2002, Billy R. Brantley and Rhonda B. Brantley executed a certain mortgage on property hereinafter described to M & F Bank f/k/a First National Bank of Shelby County, which said mortgage is recorded in Instrument #20030102000003180, in the Office of the Probate Judge in Shelby County, Alabama, and;

Mail and by publication in *The Shelby County Reporter*, a newspaper of general circulation, published in Shelby County, Alabama, in its issues of March 10, March 17 and March 24, 2010, WHEREAS, on the 1st day of April, 2010, the day on which said foreclosure sale was due to be held under the terms of said notice between the legal hours of sale, said foreclosure was duly and properly conducted and Burt W. Newsome as Attorney-in-Fact for the said Billy R. Brantley and Rhonda B. Brantley did offer for sale and sell at public outcry, at the Courthouse in Shelby County, Alabama, the property hereinafter described; and

WHEREAS, Burt W. Newsome was the Auctioneer who conducted said foreclosure sale for the said M & F Bank f/k/a First National Bank of Shelby County, and


