FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 19th day of February, 1999, Richard E. Rapier, Jr., husband, and Kathryn Rapier, wife, executed that certain mortgage on real property hereinafter described to New South Federal Savings Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 1999-08386, and re-recorded in Instrument Number 1999-32669, said mortgage having subsequently been transferred and assigned to Norwest Mortgage, Inc., by instrument recorded in Instrument Number 1999-25633, in the aforesaid Probate Office ("Transferee"); and




easements, liens, taxes, assessments, rights-of-way, and other matters of record in the aforesaid Probate Office.


