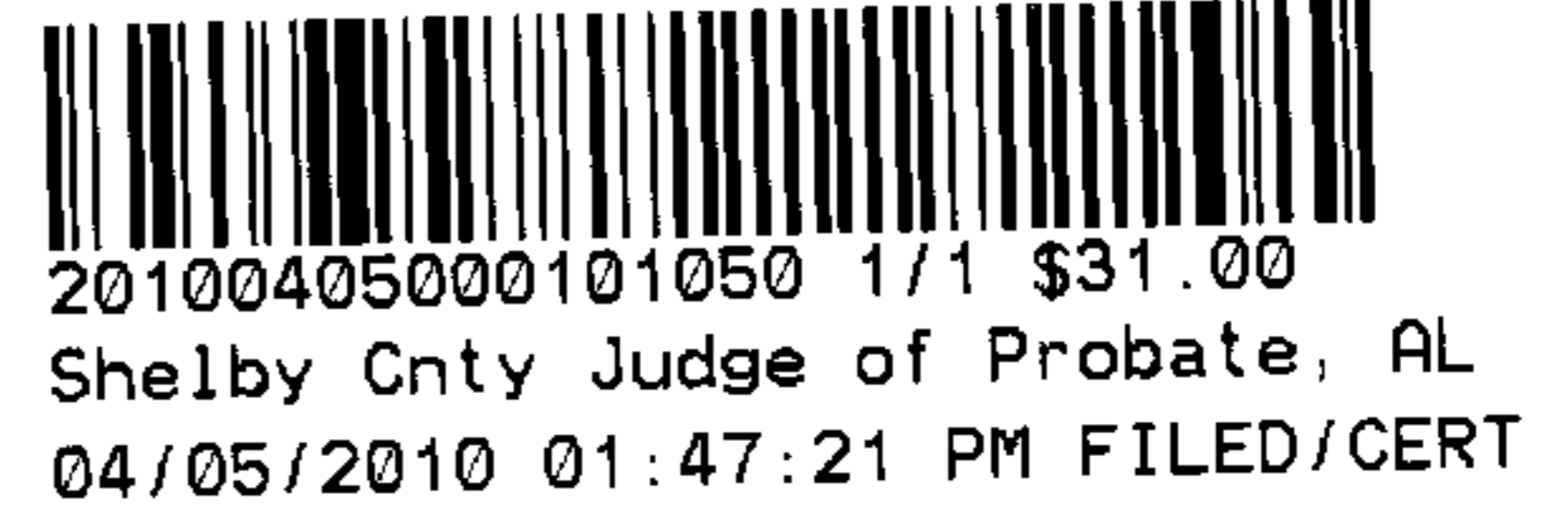

**WARRANTY DEED**

**KNOW ALL MEN BY THESE PRESENTS,** That in consideration of the sum of **Two Hundred Twenty Six Thousand dollars and Zero cents ( \$226,000.00 )** paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, **Christopher Allen Byrd and wife, Mary C. Byrd** (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto **Alan Miller and Amy H. Miller as joint tenants with rights of survivorship** (hereinafter Grantees), all of my/our right, title and interest in the following described real estate, situated in **Shelby County, Alabama:**

Lot 35, according to the Survey of Valley Station, Second Sector, as recorded in Map Book 7, Page 48, Shelby County, Alabama Records.

Subject to current taxes, all matters of public record, including, but not limited to easements, restrictions of record, and other matters which may be viewed by observation.

\$206,000.00 of the consideration recited herein is from the proceeds of a purchase money mortgage of even date herewith.

**TO HAVE AND TO HOLD** unto the said Grantees as joint tenants, with rights of survivorship, their heirs and assigns, forever; it being the intention of the parties to this conveyance that (unless the joint tenancy created is severed or terminated during the joint lives of the grantees herein) in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

Grantor does, for Grantor and for Grantor's heirs, executors and administrators covenant with the said Grantees as joint tenants, with rights of survivorship, their heirs executors and administrators, that Grantor is lawfully seized in fee simple of said premises; that it is free from all encumbrances, unless otherwise noted above; that Grantor has a good right to sell and convey the same as aforesaid; that Grantor will and Grantor's heirs, executors and administrators shall warrant and defend the same to the said Grantees, and their heirs, executors and administrators forever, against the lawful claims of all persons.
