ORDER

The Plaintiff's Motion for Summary Judgment against the Defendants Stylemark Homebuilders, Inc., Joe N. Roberts, and J. Kyle Roberts, came before the Court for hearing on February 18, 2010. Said Motion, being well taken, and after considering same, this Court hereby ORDERS, ADJUDGES and DECREES as follows:

- 1) The Court finds that Founders Kitchen & Bath, Inc. has met its burden to show that no dispute as to any material fact exists and that it is entitled to judgment as a matter of law. This Court further finds that Defendants Stylemark Homebuilders, Inc., Joe N. Roberts, and J. Kyle Roberts, are unable to rebut that showing.
- Accordingly, the Court hereby enters judgment against Defendants Stylemark Homebuilders, Inc., Joe N. Roberts, and J. Kyle Roberts, in the amount of \$21,000.00 for the principal debt; \$3,780.00 in prejudgment interest per contract, and \$6,999.93 in attorney's fees, which this court expressly finds as reasonable; for a total judgment to be entered against the Defendants Stylemark Homebuilders, Inc., Joe N. Roberts, and J. Kyle Roberts in the amount of \$31,779.93.
- 3) As against Defendant Stylemark Homebuilders, Inc., the verified statement of lien, Instrument No. 20090506000168710 (filed May 6, 2009), was properly filed and is hereby perfected
