KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 22nd day of February, 2008, Barry P. Wynn and Vanessa Vienna-Wynn, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as nominee for Countrywide Bank, FSB, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20080320000114220, said mortgage having subsequently been transferred and assigned to BAC Home Loans Servicing, L.P., ("Transferee"); and

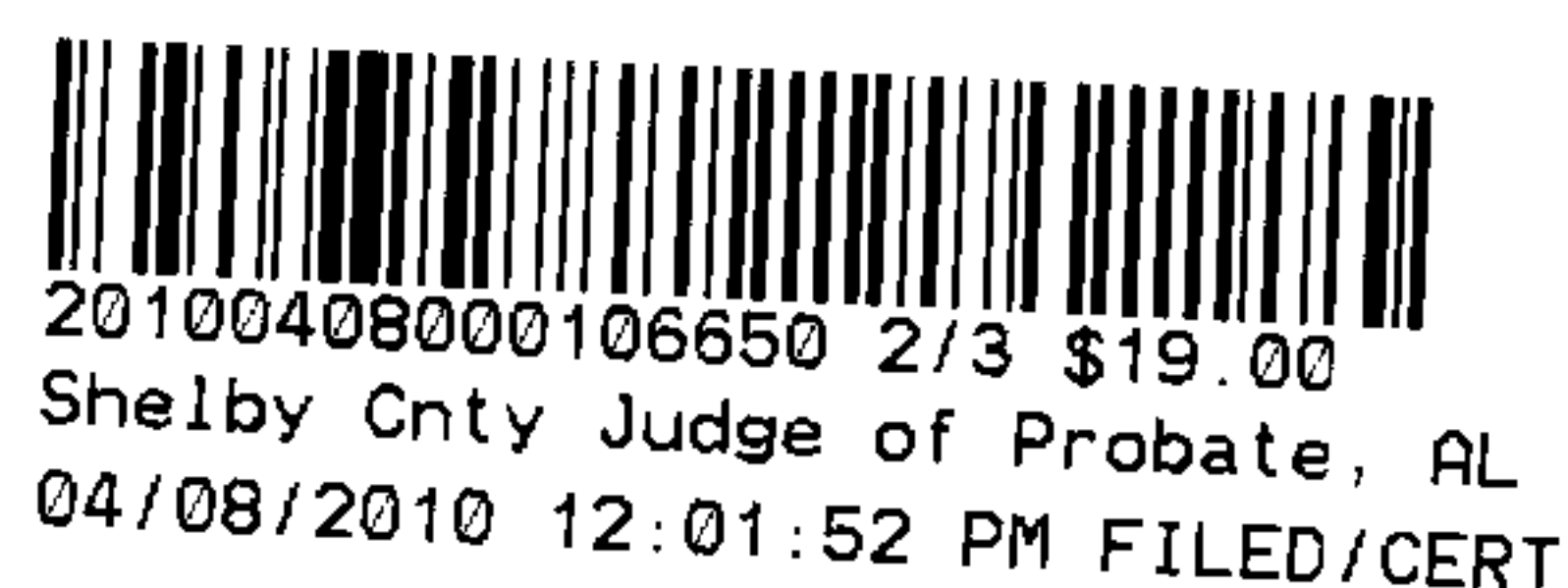

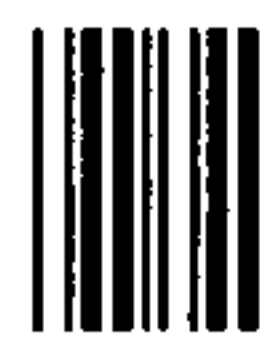
