**ARTICLES OF ORGANIZATION  
OF IMCASTLE, LLC**

The undersigned, for the purpose of forming a limited liability company under Title 10, Chapter 12 of the *Code of Alabama* (1975), as amended (the "Act"), hereby files the following Articles of Organization with the Office of Probate Judge of the county in which the initial registered office of the limited liability company will be located and affirms that the facts stated in these Articles of Organization are true and correct.

**SECTION 1. NAME OF COMPANY**

The name of the limited liability company is IMCASTLE, LLC (the "Company").

**SECTION 2. PURPOSES**

The purposes for which the Company are organized are as follows:

- a) To own and operate a website design and development business and ancillary services; and
- b) To exercise all other powers and do all things that a professional limited liability company organized and existing under the Act may do, and to engage in all activities that may not or hereafter be necessary, appropriate, convenient, or helpful to any of the foregoing.

**SECTION 3. INITIAL REGISTERED OFFICE AND AGENT FOR SERVICE OF  
PROCESS**

The location and mailing address of the initial registered office of the Company shall be 103 Big Oak Drive, Maylene, AL 35114. The name of the initial registered agent for service of process at the foregoing address shall be Joanna Reiter.

#### **SECTION 4. ORGANIZER AND INITIAL MEMBER**

The organizer of the Company is Carol Armstrong, whose address is 2809 8th Street, Tuscaloosa, Alabama 35401.

The name and mailing address of the initial member of the Company is as follows:

Subject to the requirements of the Act, the membership interests shall be divided into such classes and shall have such relative rights, powers, and duties as are provided in the Operating Agreement of the Company, as in effect from time to time (the "Operating Agreement").

#### **SECTION 5. ADDITIONAL MEMBERS**

Additional members may be admitted only upon the unanimous written consent of the then existing members, as may be further provided in the Company's Operating Agreement, if any. *Transfers of membership interests in the Company may be subject to certain restrictions as set forth in the Operating Agreement, if any.*

#### **SECTION 6. MANAGEMENT**

The Company shall be managed by its member, subject to the terms and conditions of the Operating Agreement, if any.


#### **SECTION 7. DISSOLUTION OF THE COMPANY**

The Company shall not be dissolved by the cessation of membership of one or more of its members, and shall otherwise be dissolved as provided in the Operating Agreement, if any, or by the Act.
