

GENERAL DURABLE POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENT, That I,
Elaine F. Reynolds Residing at 477 Reynolds Rd,
Vincent, AL, ALABAMA do hereby nominate, constitute, and
appoint Patricia Scroggins,
of Vincent, ALABAMA, as my true and lawful
attorney-in-fact, for me and in my name, place and stead, and for my use and
benefit.

To ask, demand, sue for, recover, collect and receive all sums of money,
debts, dues, and accounts, legacies, bequests, interest, dividends, annuities,
and whatsoever as are now or shall hereafter become due, owing, payable, or
belonging to me and have, use, and take all lawful ways and means in my
name or otherwise, and to compromise and agree to the same and give a
quittance or other sufficient discharges for same;

For me and in my name to make, seal and deliver, bargain, contract, agree
for, purchase, receive, and take lands, tenements, and hereditaments, and
accept the possession of all lands, and all deeds and other assurances, in the
law therefore, and to lease, let, demise, sell, promise, release, convey,
mortgage, and hypothecate lands, tenements, and hereditaments upon such
terms and conditions and under such covenants as he shall think fit:

Also to bargain and agree to buy, sell, mortgage, hypothecate, and in any
and every way manner deal in and with goods, wares, and merchandise,
choices in action, and other property in possession or in action, and to make,
do and transact all and every kind and of business of whatsoever nature and
kind;

And also for me and in my name, and as my act and deed, to sign, seal,
execute, deliver, and acknowledge such deeds, leases, mortgages,
hypothecations, bills of lading, bills, bond, notes, receipts, evidence of debt,
releases and satisfaction of mortgage, judgments and other debts, and other

such other instruments in writing of whatsoever nature and kind as may be necessary or proper in premises;

GIVING AND GRANTING unto my said attorney-in-fact, full power and authority to do and perform every act necessary, requisite, or proper to be done in and about the premises as fully as I might or could do if personally present, with full power of substitution and revocation, hereby ratifying and confirming all that my said attorney shall lawfully do or cause to be done by virtue hereof.

This power of attorney shall not be affected by my disability, in competency or incapacity. If, following execution of this power of attorney, a court of my domicile appoints a guardian, creator or other fiduciary charges with the management of all of my property, or all such property specified exclusions, the court shall appoint Pat Scaggs, except for good cause or disqualification.
