KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 26th day of October, 2001, Scott B. Wiggins, a married man joined herein by his wife, Lynn E. Wiggins, executed that certain mortgage on real property hereinafter described to Union Planters Bank, N.A., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 2001-47411, said mortgage having subsequently been transferred and assigned to EverBank , by instrument recorded in Instrument No. 20080818000332570, in the aforesaid Probate Office ("Transferee"); and

WHEREAS, on April 6, 2010, the day on which the foreclosure was due to be held under the terms of said notice, between the legal hours of sale, said foreclosure was duly conducted, and EverBank did offer for sale and sell at public outcry in front of the Courthouse door in Columbiana, Shelby County, Alabama, the property hereinafter described; and

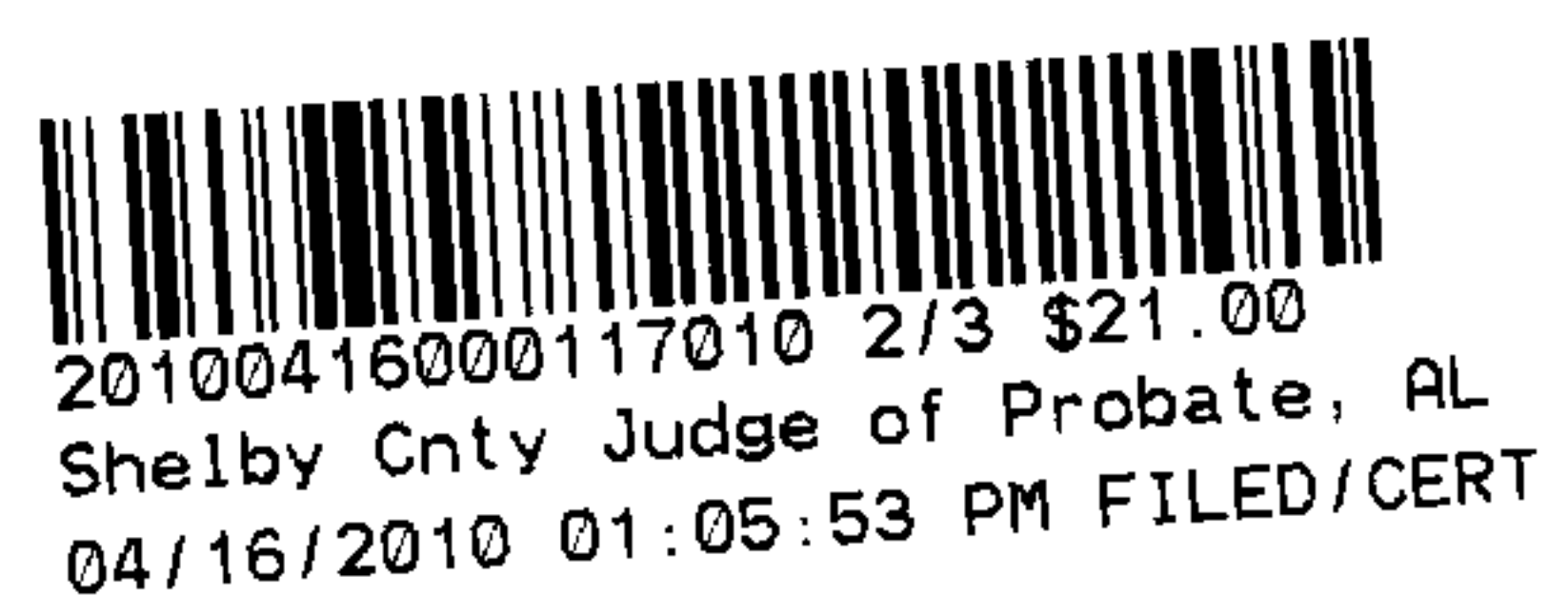


