AUCTIONEER'S DEED

WHEREAS, SON HUYNH, an unmarried person, executed a mortgage to MORTGAGE ELECTRONIC REGISTRATION SYSTEMS, INC. 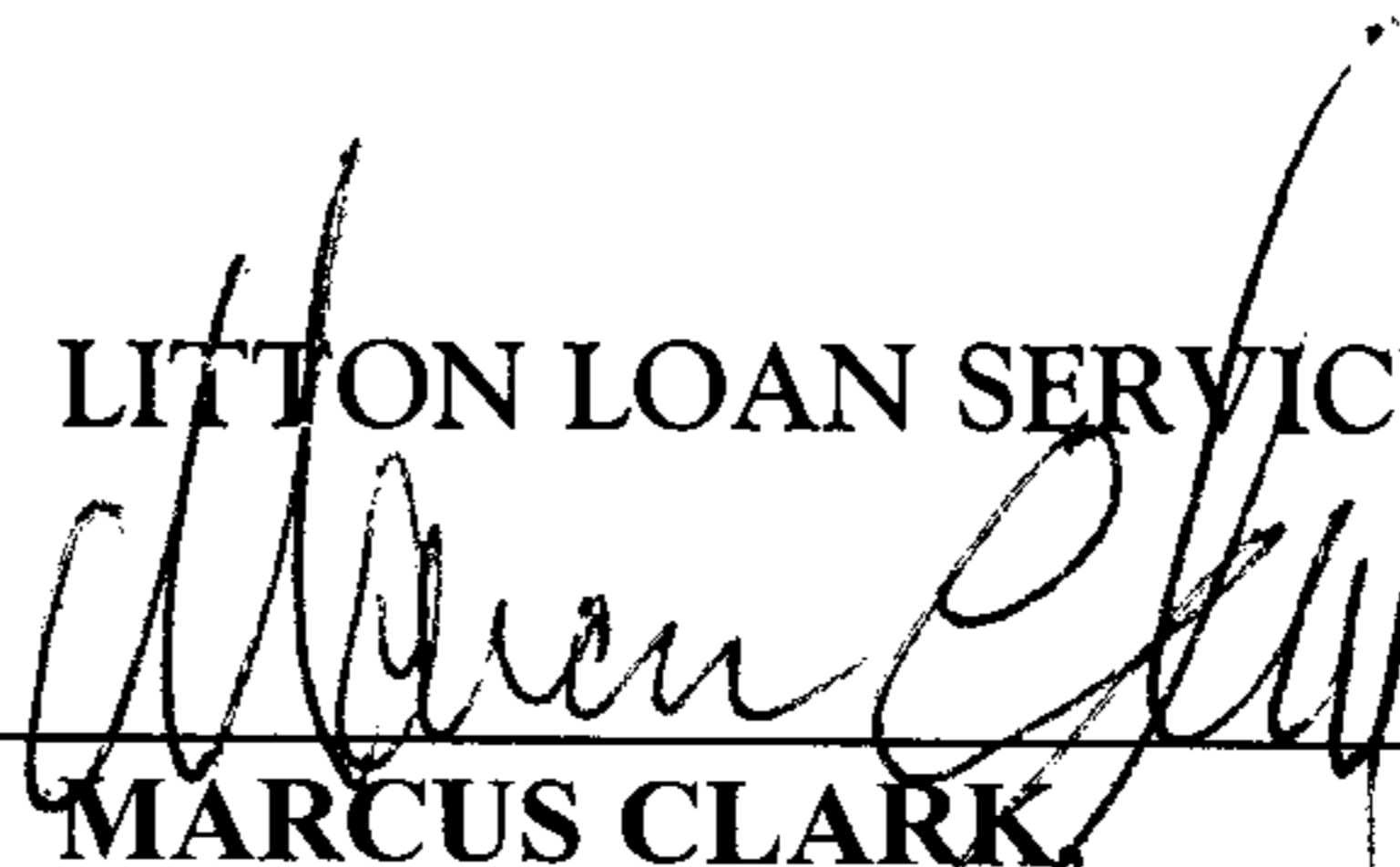
