**KNOW ALL MEN BY THESE PRESENTS:** That, for and in consideration of **One Hundred Fifty-Six Thousand and 00/100 (\$156,000.00)**, and other good and valuable consideration, this day in hand paid to the undersigned **Jackie S. Cross, and husband, Bobby L. Cross**, (hereinafter referred to as GRANTORS), in hand paid by the GRANTEES herein, the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEES, **G. DuWane Hooper and Myra L. Hooper**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of **Shelby**, State of Alabama, to-wit:

**Lot 117, according to the Map of Highland Lakes, 1st Sector, an Eddleman Community, as recorded in Map Book 18, Pages 37 A, B, C, D, E, F, & G, in the Probate Office of Shelby County, Alabama.**

**Together with nonexclusive easement to use the private roadways, Common Area all as more particularly described in the Declaration of Easements and Master Protective Covenants for Highland Lakes, a Residential Subdivision, recorded as Instrument #1994-07111 and amended in Instrument #1996-17543, Second Amendment recorded in Instrument # 1999-31095 in the Probate Office of Shelby County, Alabama, and the Declaration of Covenants, Conditions and Restrictions for Highland Lakes, a Residential Subdivision, 1st Sector, recorded as Instrument #1994-07112 in the Probate Office of Shelby County, Alabama (which, together with all amendments thereto, is hereinafter collectively referred to as, the "Declaration").**





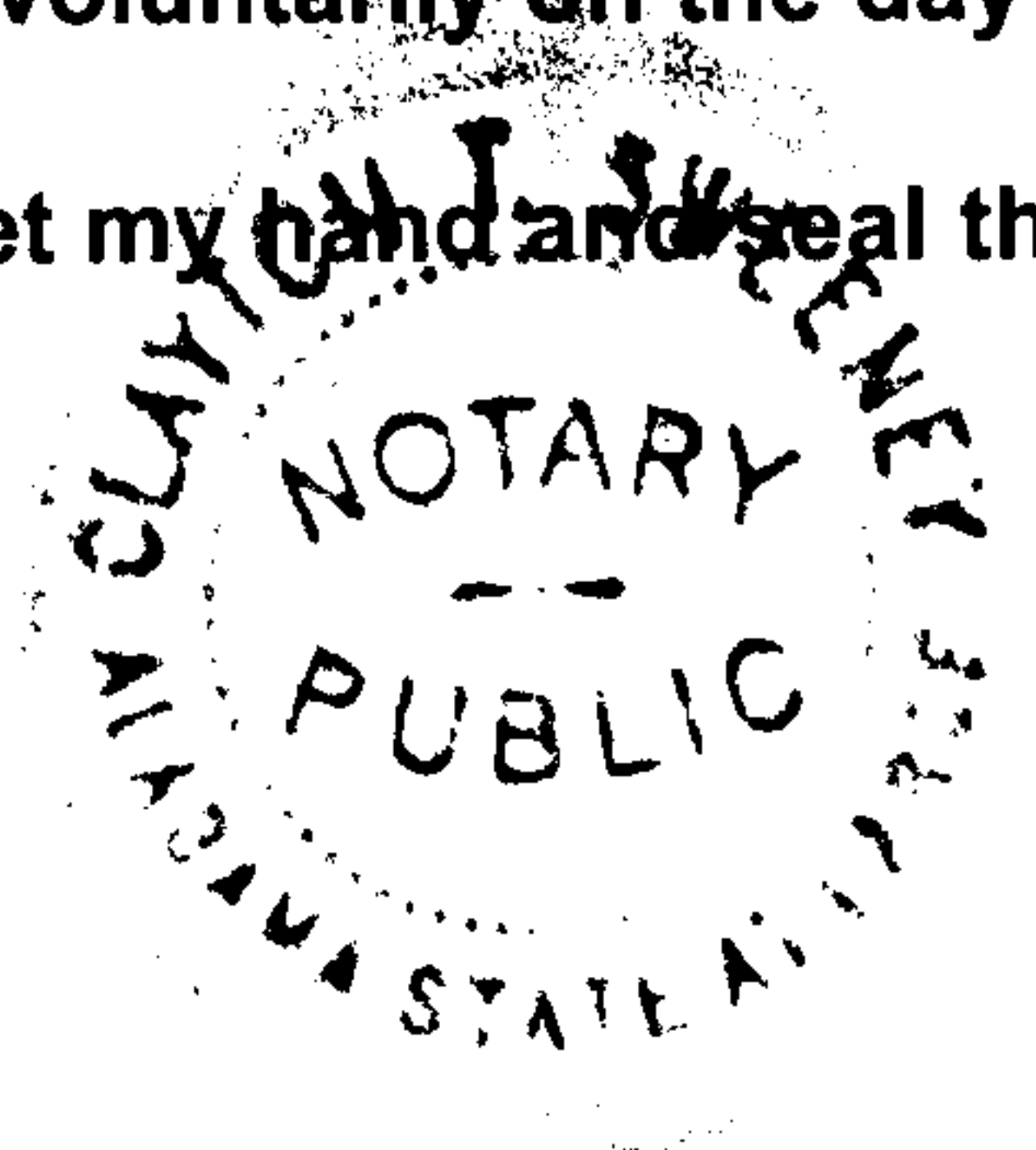
