KNOW ALL MEN BY THESE PRESENTS, That whereas heretofore on to-wit: the 30th day of May, 2006, Jerry D. Walker and Mary F. Walker, husband and wife, executed a certain mortgage on the property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for Wachovia Mortgage Corporation, as recorded in Instrument No. 20060607000268860 in the Probate Office of Shelby County, Alabama.


