## ORDINANCE NO. 100405

WHEREAS, on or about the 1<sup>st</sup> day of March, 2010, William S. 
1. That the Town of Wilsonville, Alabama, does adopt this Ordinance assenting to the annexation of the property owned by the above referenced property owners, as described in:

- 3. That the Town Clerk be and she is hereby authorized and directed to file a copy of this Ordinance, including an accurate description of the property being annexed, together with a map of the said property showing its relationship to the corporate limits of the Town of Wilsonville, Alabama, to which said property is being annexed in the office of the Judge of Probate of Shelby County, Alabama.

That the Zoning Map of the Town of Wilsonville, Alabama, and any other official maps or surveys of the Town shall be extended to reflect the annexation of the above described property, and that a copy of this Ordinance be transmitted to the Town Planning Commission and the Zoning Administrator.
