FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 23rd day of January, 2007, Cynthia H. Phelps and James David Phelps, as joint tenants with full rights of survivorship, wife and husband, executed that certain mortgage on real property hereinafter described to Argent Mortgage Company, LLC, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20070206000055280, said mortgage having subsequently been transferred and assigned to U.S. Bank, N.A., as trustee for CMLT 2007-AMC4, ("Transferee"); and
