

ORDINANCE NO. 10-2190

AN ORDINANCE DE-ANNEXING CERTAIN PROPERTY FROM THE CITY OF HOOVER

BE IT ORDAINED by the City Council of the City of Hoover, Alabama, in regular meeting duly assembled, a quorum being present, as follows:

SECTION 1. Whereas a petition signed by <u>Alex D. Baker, AIG Baker East Village, LLC</u> presented to the City Clerk of the City of Hoover, Alabama, a copy of which is attached hereto and marked Exhibit "A", requesting the property described therein be de-annexed from the City of Hoover, said property being situated in Shelby County, Alabama, and described as follows:

SECTION 2. That the City Council of the City of Hoover, Alabama hereby finds that said property was annexed into the City limits of the City of Hoover and should now be de-annexed, and it is in the best interest of the City of Hoover that said property be de-annexed and the City of Hoover does hereby assent to the de-annexation of said property from the City of Hoover, Alabama.

SECTION 3. The City Clerk shall file a certified copy of this ordinance containing an accurate description of said de-annexed territory with the Probate Judge of Shelby County, Alabama, and also cause a copy of this ordinance to be published in a newspaper of general circulation in the City of Hoover.






STATE OF ALABAMA SHELBY COUNTY

A parcel of land situated in the Southeast Quarter of the Southwest Quarter of Section 5, Township 19 South, Range 1 West, Shelby County, Alabama, being more particularly described as follows:

Commence at a found 2" capped pipe purported to be the Northwest Corner of the Southeast quarter of the Southwest quarter of Section 5, Township 19 South, Range 1 West, Shelby County, Alabama; thence proceed S 00°35'54" E along the West line of said Southeast Quarter of Southwest Quarter for 663.92 feet to the Southwest corner of the North Half of the Southeast Quarter of the Southwest Quarter of Section 5, Township 19 South, Range 1 West, Shelby County, Alabama; thence proceed N 89°01'27" E along said South line of said North Half of Southeast Quarter of Southwest Quarter for 78.79 feet to the **POINT OF BEGINNING**; thence continue N 89°01'27" E along said South line of said North Half of Southeast Quarter of Southwest Quarter for 919.76 feet to a point; thence proceed N 00°28'01" W for 35.63 feet to a point; thence proceed S 88°58'49" W for 802.65 feet to a point at the beginning of a curve to the left, said curve having a radius of 215.00 feet, a central angle of 33°06'51" and a chord which bears S 72°25'23" W for 122.54 feet; thence proceed Southwesterly along the arc of said curve for 124.26 feet to the **POINT OF BEGINNING**.
