KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 1st day of October, 2007, Mary Farris, an unmarried woman, executed that certain mortgage on real property hereinafter described to Pinnacle Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20071005000467510; having been re-recorded in Instrument Number 20080125000033240, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, N.A., by instrument recorded in Instrument Number 20090401000118950, in the aforesaid Probate Office ("Transferee"); and
