**ARTICLES OF ORGANIZATION
OF

I, the undersigned, desiring to form a Limited Liability Company pursuant to the laws of The State of Alabama, certify as follows:

1. **Name.** The name of the Limited Liability Company is Bayou Deli, LLC
2. **Duration.** The existence of Limited Liability Company shall commence on the Date of the filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, and shall continue until December 31, 2060, provided, however, that the Limited Liability Company shall be dissolved prior to such date (a) upon the written consent of (b) as provided in the Operating Agreement; or (c) as may be required by the Alabama Limited Liability Company Act.
3. **Purposes.** The purpose for which this Limited Liability Company is Organized is to Operate a food establishment to serve the public and to acquire and hold real and personal property of every kind and character. Engage in any lawful business permitted under the laws of the State of Alabama.

6. ***Admission of Additional Members.*** The member or members of the Limited Liability Company shall have the right to admit additional members to the Limited Liability Company upon the unanimous consent of all the members of the Limited Liability Company.

7. ***Cessation of Membership.*** The member or members of the Limited Liability Company shall have the right to continue the business of the Limited Liability Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member of the Limited Liability Company if (i) there are at least two remaining members or at least one remaining member and the member is admitted; and (ii) the legal existence and business of the Limited Liability Company is continued by a written consent of all the remaining members within ninety (90) days after the occurrence of the event of dissociation.

8. ***Managed by Member.*** The business and affairs of the Company shall be managed and conducted by Gary D. Tynes, who shall have the power to manage the business and affairs of the company as provided in the Operating Agreement.
