FIRST AMENDMENT TO MORTGAGE, SECURITY AGREEMENT, ASSIGNMENT OF LEASES AND RENTS, FINANCING STATEMENT AND FIXTURE FILING

THIS FIRST AMENDMENT TO MORTGAGE, SECURITY AGREEMENT, ASSIGNMENT OF LEASES AND RENTS, FINANCING STATEMENT AND FIXTURE FILING (this "Amendment"), is made as of May 12", 2010, by GREDE II LLC, a Delaware limited liability company ("Mortgagor"), with its principal office at 27275 Haggerty Road, Suite 420, Novi, Michigan 48377 to GENERAL ELECTRIC CAPITAL CORPORATION, a Delaware corporation, with an address of 201 Merritt Seven, 4th floor, Norwalk, Connecticut 06851, as mortgagee, assignee and secured party in its capacity as administrative agent on behalf of itself as lender and for the "Lenders", as hereinafter defined (together with any successors or assigns in such capacity, the "Agent" or "Mortgagee"). NOW, THEREFORE, for and in consideration of the premises, TEN DOLLARS (\$10.00) in hand paid and other good and valuable considerations, the receipt, adequacy and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. <u>Grant</u>. In order to secure the prompt and complete payment or performance in full when due of the Secured Indebtedness, Mortgagor hereby irrevocably mortgages, grants, bargains, sells, conveys, assigns, releases, aliens, transfers, warrants, sets over and confirms UNTO Mortgagee and its successors and assigns (for the benefit of the Lenders) forever TO HAVE AND TO HOLD THE Additional Premises, together with all privileges and appurtenances thereunto belonging to Mortgagee, including power of sale, and the other property described in the Mortgage (collectively, the "<u>Additional Premises</u>"). Mortgagor does hereby bind itself, its

- 2. <u>Amendments to Mortgage</u>. Effective as of this date, the Mortgage has been and is hereby amended as follows:
- 2.1 By adding Exhibit A attached to this Amendment to Exhibit A attached to the Mortgage;
- 2.2 By modifying and amending the definition of "Premises" in the Mortgage to mean collectively the Premises described in the Mortgage and the Additional Premises described in this Amendment; and
- 2.3 By redefining the term "Mortgage", as used in the Mortgage, so that such term shall mean and refer to the Mortgage, as amended by this Amendment.
- 3. <u>No Other Change</u>. Except as herein expressly amended, each and every term, condition, warranty and provision of the Mortgage shall remain in full force and effect, and such are hereby ratified, confirmed and approved by the parties hereto. Nothing herein shall be construed to alter or affect the priority of the lien or title created by the Mortgage, it being the expressly declared intention of the parties hereto that no novation of the Loan Documents (as defined in the Credit Agreement) be created hereby.
- 4. <u>Entire Agreement</u>. This Amendment and the Mortgage, as the same has been amended by this Amendment, set forth the entire understanding of the parties with respect to the matters set forth herein and therein, and shall supersede any prior negotiations, commitment letters, or agreements, whether written or oral, with respect to such matters.
- 5. <u>Binding Effect</u>. This Amendment shall be binding upon and shall inure to the benefit of the parties hereto, their respective successors, legal representatives and assigns.
- 6. <u>Counterparts</u>. This Amendment may be executed in any number of counterparts and by different parties hereto in separate counterparts, all of which taken together shall constitute but one and the same instrument.
- 7. Governing Law. This Amendment shall be governed by and shall be construed and enforced in accordance with the internal laws of the State of New York, without regard to conflicts of law principles, except to the extent Alabama law necessarily applies because the Property is located in the State of Alabama. This Amendment shall further be subject to Section 5.16 of the Mortgage.
