STATUTORY WARRANTY DEED

STATE OF ALABAMA

SHELBY COUNTY KNOW ALL MEN BY THESE PRESENTS,


That in consideration of the distribution of the estate of David Ray Reynolds, deceased, in accordance with his will probated in Case No. PR-2009-000673 in the Probate Court of Shelby County, Alabama, the undersigned Patricia A. Scoggins, personal representative of said estate (herein referred to as GRANTOR) does grant, bargain, sell and convey unto Hayden Keith Laddie (herein referred to as GRANTEE) the following described real estate situated in Shelby County, Alabama to-wit:

A tract of land located in the S $\frac{1}{2}$ of the SW $\frac{1}{4}$ of Section 17, Township 19 South, Range 2 East, and being more particularly described as commencing at the Northwest corner of the SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of said Section 17 and run North 89° 34' East along the North line of said $\frac{1}{4}$ - $\frac{1}{4}$ 1833.3 feet to a point; thence South 0° 26' East 1120.15 feet to the point of beginning; thence continue along last described course 200 feet to the South line of said Section 17; thence South 89° 34' West along the South line of said Section 17 for 417 feet to a point; thence North 0° 26' West 200 feet; thence North 89° 34' East 417 feet to the point of beginning.

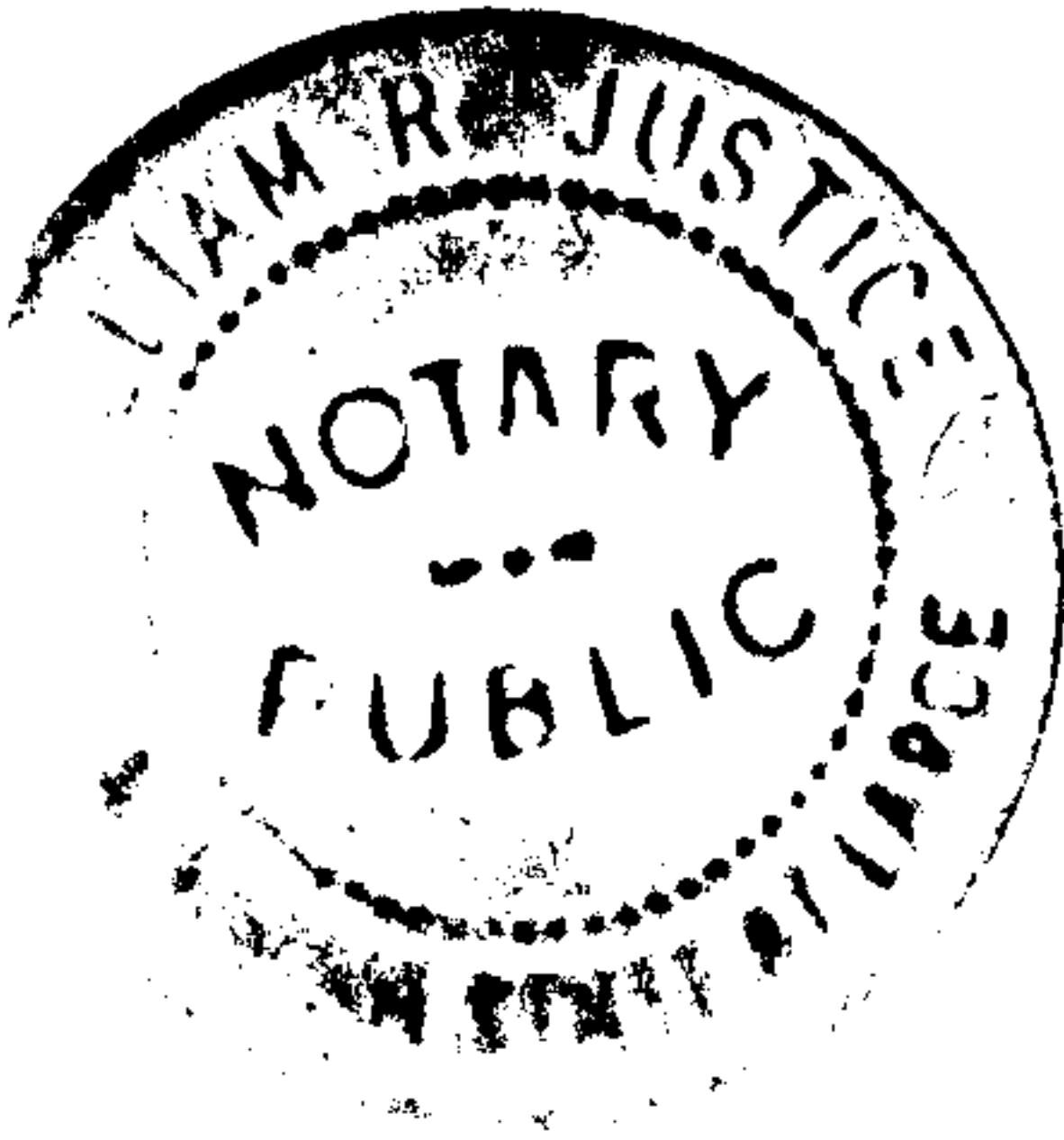
