ARTICLES OF ORGANIZATION

OF

ARTICLE I Name

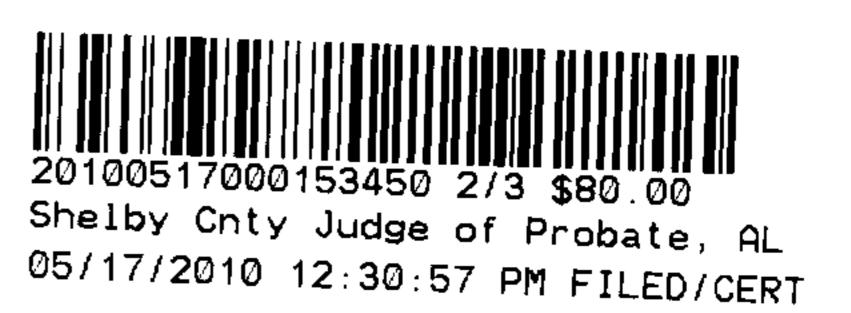
The name of the limited liability company ("Company") is ALCHLO, L.L.C.

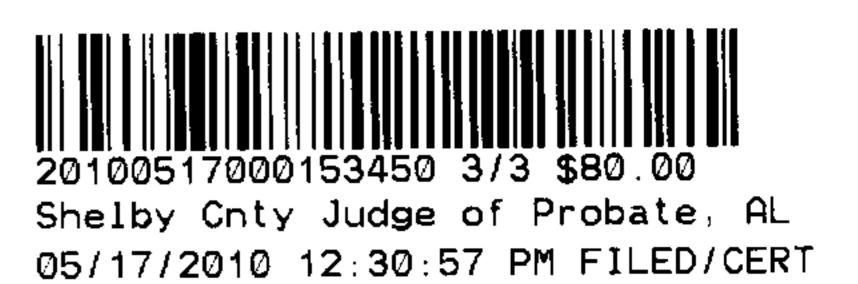
