That said Association claims a lien upon property owned by **Thomas and Nancy G. Keen** situated in Shelby County, Alabama described as follows:

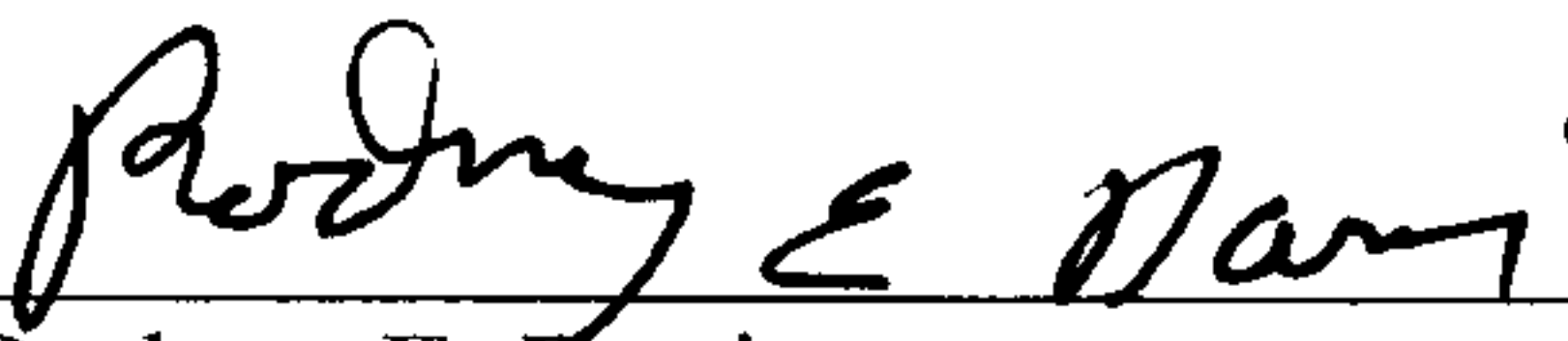
