That said Association claims a lien upon property owned by **Alan D. Lyons and Jayne Ivy Lyons** situated in Shelby County, Alabama described as follows:


Lot 416, according to the MAP and Survey of Windstone IV Subdivision, as recorded in Map Book 27, Page 55, Shelby County, Alabama.
