FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 16th day of August, 2004, Audrey M. Sanders, a single individual, executed that certain mortgage on real property hereinafter described to Washington Mutual Bank, FA, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20040930000540940, and
