


Subordination Agreement

THIS AGREEMENT is made and entered into on this _____10th March 2010. by <u>Wachovia Mortgage</u> Corporation.(hereinafter referred to as "Beneficiary" in favor of Wells Fargo Bank N.A., it's successors and assigns (hereinafter referred to as ____Lender_).

WITNESSETH

WHEREAS, Wachovia Mortgage Corporation did loan Richard M. Gilley and Sybil J. Gilley ("Borrower") the sum of \$123,000.00 which loan is evidenced by a promissory December 14, 2007 executed by Borrower in favor of Wachovia Mortgage Corporation. and is secured by a Deed of Trust/Mortgage even date therewith (the "Second Loan") covering the property described therein and recorded as Instrument Number 20071221000573640 Libor page and of the real property records in the office of Shelby County State of Alabama and WHEREAS, Borrower has requested that <u>Lender</u> lend to it the sum of \$409,481.00 "loan"), such loan to be evidenced by the promissory note dated ___ March 31.2010. executed by Borrower in favor of <u>Lender</u> and secured by a Mortgage of even date therewith (the "New Mortgage") covering in whole or in part of the property covered by the Mortgage: and * Recorded on: 415/2010/Instrument #: 20100405000101380 WHEREAS, ____ Lender ____ has agreed to make a loan to the Borrower, if, but only if, the New Mortgage shall be and remain a lien or charge upon the property covered thereby prior and superior to the lien or charge of the Mortgage and provided that Beneficiary will specifically and unconditionally subordinate the lien or charge of the Mortgage to the lien or charge of the New Mortgage of Lender. NOW, THEREFORE, in consideration of One Dollar and in consideration for the premises and for other good and valuable consideration, the receipt and sufficiency all of which is hereby acknowledged, and in to make the Loan above referred to, Beneficiary agrees as follows: order to induce <u>Lender</u> 1. The New Mortgage and the note secured thereby and the debt evidenced by such and any and all renewals and interest payable on all of said debt and on any and all such renewals and extensions shall be and retain at all times a lien or charge on the property covered by the New

Mortgage, prior and superior to the lien or charge of the Mortgage in favor of Beneficiary.



- 2. <u>Beneficiary</u> acknowledges that it intentionally waives, relinquishes, and subordinates the priority and superiority of the lien or charge of the Mortgage in favor of the lien or charge of the New Mortgage in favor of <u>Lender</u> and that it understands that in reliance upon and in consideration of this waiver, relinquishment, and subordination specific loans and advances are being and will be made, and as part and parcel thereof specific monetary and other obligations are being and will be entered into by <u>Lender</u> which would not be made or entered into but for such reliance upon this waiver, relinquishment, and subordination.
- 3. This agreement contains the entire agreement between the parties hereto as to the loan secured by the Mortgage and the Loan secured by the New Mortgage, and the priority thereof, and there are no agreements, written or oral, outside or separate from this agreement and all prior negotiations are merged into this agreement.
- 4. This agreement shall insure to the benefit of and be binding upon the successors and assigns of the parties.

This Subordination Agreement shall become invalid in the event that the new first loan amount exceeds \$409,481.00


