

KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of One Hundred Thirty-Two Thousand & No/100 Dollars (\$132,000.00) and other good and valuable consideration to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged HORACE E. BERRY, A MARRIED MAN AND BARBARA B. FOWLER, AN UNMARRIED WOMAN (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto Kathy Hawkins and Leonard Hawkins referred to as "Grantee"), as joint tenants with rights of survivorship, the following described real estate situated in Shelby County, Alabama, to wit:

Lot 95 according to the Survey of Laurel Woods, Phase IV, as recorded in Map Book 18 page 97 in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.

Subject to all easements, restrictions, covenants, rights of way of record; taxes for 2004 and subsequent years not yet due and payable.

\$ 105,600.00 of the purchase price recited herein was paid from the proceeds of a mortgage loan closed simultaneously herewith.

The property described herein is not the homestead of Horace E. Fowler nor of his spouse.
