

**ARTICLES OF INCORPORATION  
OF

Pursuant to the provisions of the Alabama Business Corporation Act, the undersigned hereby adopts the following Articles of Incorporation.

1. The name of the corporation is Alora Consulting, Inc.
2. The duration of the corporation is perpetual.
3. The purpose of the corporation is sales consulting or any other lawful purposes.
4. The corporation shall have the authority to issue 10,000 shares, par value \$0.01.
5. The street address of the initial registered agent shall be 14106 Kenley Way, Birmingham, AL 35242.
6. The name of the initial registered agent is Amanda Slocumb.

The number of directors constituting the board of directors shall be between one and five, the exact number within such range to be determined by resolution of the shareholders at the annual meeting.

The corporation shall indemnify any director or officer who was or is a party or is threatened, to be made a party to any threatened, pending, or completed action, suit or proceeding, whether civil, criminal, administrative or investigative (other than an action by or in the right of the corporation) by reason of the fact that he is or was a director, officer, employee or agent of the corporation, or is or was serving at the request of the corporation as a director, officer, employee or agent of another corporation, partnership, joint venture, trust or other enterprise, against expenses (including attorneys' fees), judgments, fines and amounts paid in settlement actually and reasonably, incurred by him in connection with such action, suit or proceeding to the fullest extent permitted by law.
