The authority hereby granted shall expire AUGUST 1, 2010 unless sooner revoked.

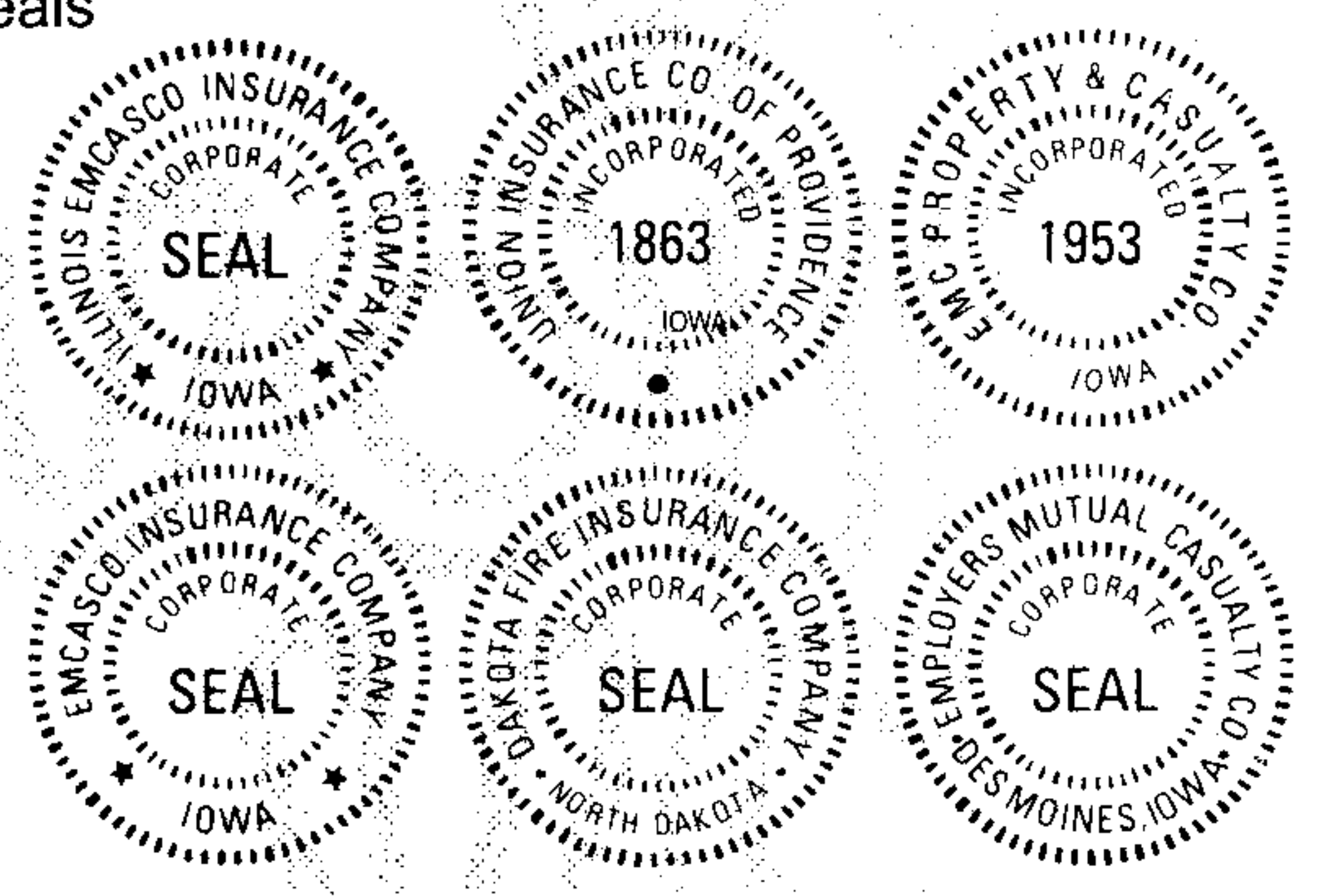
## AUTHORITY FOR POWER OF ATTORNEY
