WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of **Two Hundred Forty Five Thousand dollars and Zero cents (\$245,000.00)** paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, **Ronald H. Grizzle and Penelope A. Grizzle, Husband and Wife** (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto **Jill S. Riley and Terry W. Riley as joint tenants with rights of survivorship** (hereinafter Grantees), all of my/our right, title and interest in the following described real estate, situated in **Shelby County, Alabama:**

Lot 103, according to the Amended Map of Riverwoods, First Sector, as recorded in Map Book 29, Page 120, in the Office of the Judge of Probate of Shelby County, Alabama.
