### Domestic Limited Liability Company Articles of Organization Guidelines

#### Instructions:

- Step 1:** The name of the Limited Liability Company must contain the words Limited Liability Company, LLC or L.L.C.
- Step 2:** File the original and two copies of the Articles of Organization in the county where the LLC's registered office is located. The Judge of Probate's filing fee is \$35 and the Secretary of State's filing fee is \$40.

Pursuant to the provisions of the Alabama Limited liability Company Act, the undersigned hereby adopts the following Articles of Organization.

- Article V*      The name(s) and address(es) of the initial member(s), and, if any, organizer. (Attach additional sheets if necessary).


