Samples Schiefer, husband and wife** (hereinafter referred to as GRANTORS), the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEE, **Carra L. Wright, a single individual**, (hereinafter referred to as GRANTEE), her heirs and assigns, the following described Real Estate, lying and being in the County of SHELBY, State of Alabama, to-wit:

\$97,000.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.


Shannon E. Samples and Shannon E. Samples Schiefer are one and the same person.

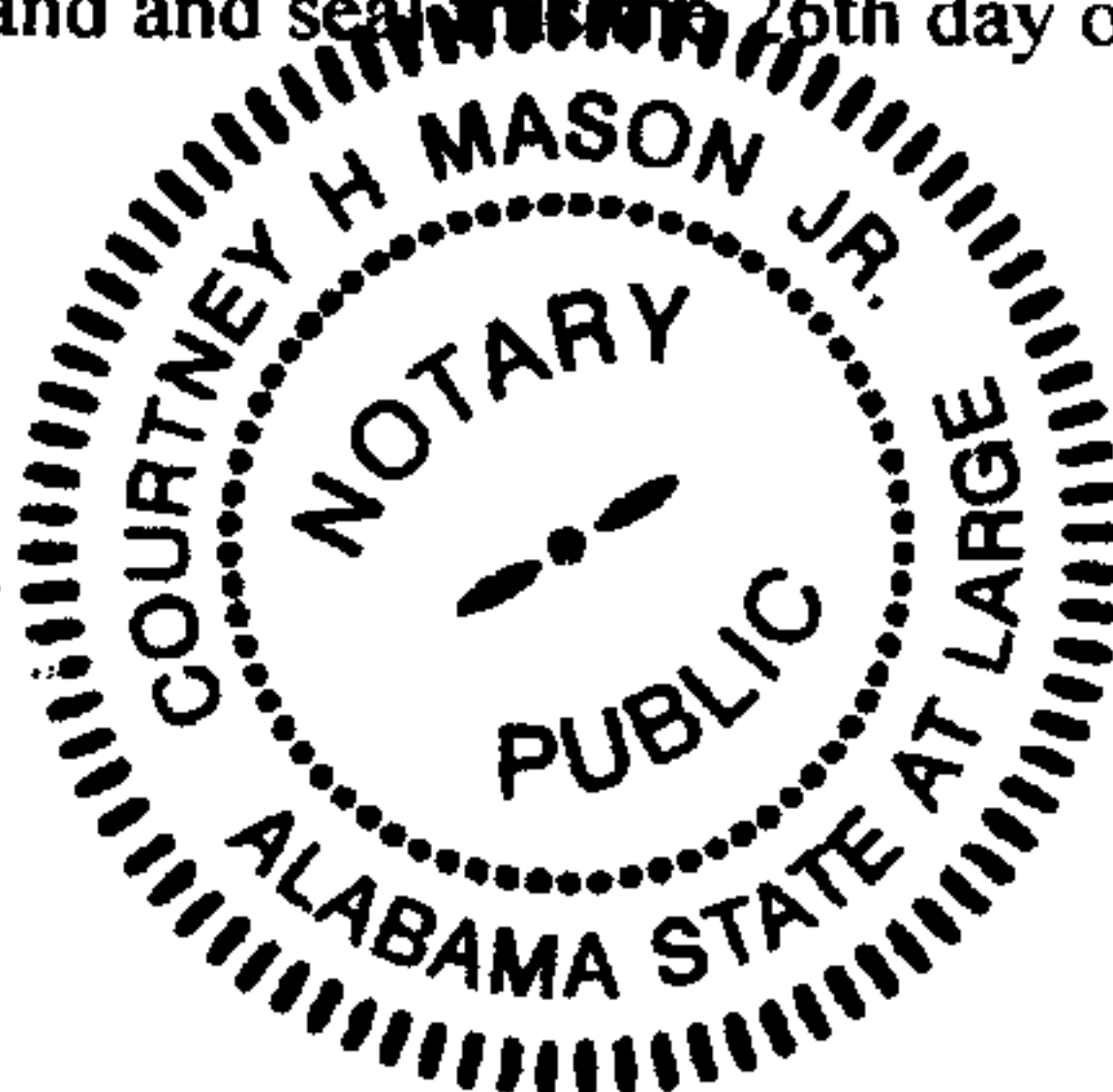
