

## MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore, on to-wit, October 29, 2007, Michael Lee Dyksterhouse and Gina I. Dyksterhouse, husband and wife, Mortgagors, did execute a certain mortgage to Wachovia Bank, National Association, which said mortgage is recorded in Instrument No. 20071116000525780, and rerecorded in Instrument No. 20100202000031770, in the Office of the Judge of Probate of Shelby County, Alabama; and
