


## ***CERTIFICATION***

**A RESOLUTION RATIFYING THE FINAL PLAT OF COLONIAL PROMENADE ALABASTER, AS RECORDED IN MAP BOOK 32, PAGES 102A and 102B IN THE OFFICE OF THE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA.**

**WHEREAS**, on or about August 19, 2005 Colonial Properties Services, Inc. recorded a Final Plat of the Colonial Promenade Alabaster Subdivision in the Office of the Judge of Probate of Shelby County, Alabama; and,

**WHEREAS**, said map was defective in that it did not record the acquiescence of the City of Alabaster, Alabama, as an owner of certain property located within the boundaries of said Final Plat; and

**WHEREAS**, the City of Alabaster wishes to clear any and all title issues created by the lack of acknowledgement of the City of Alabaster as to the Final Plat of Colonial Promenade Alabaster, as recorded in Map Book 32, Pages 102A and 102B in the Office of the Judge of Probate of Shelby County, Alabama; and


**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Alabaster as follows:




