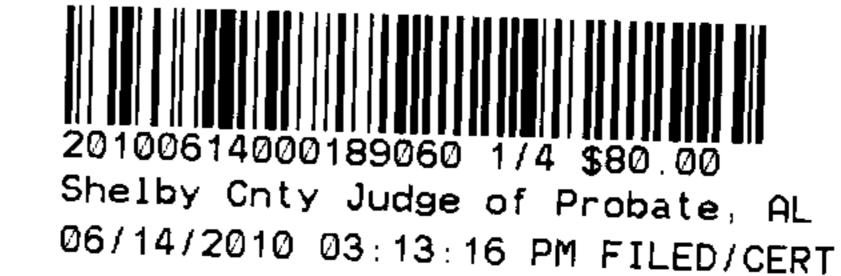

ARTICLES OF ORGANIZATION

OF

C & S SHOALS, LLC

- 1. The name of the limited liability company is C & S Shoals, LLC, hereinafter referred to in these Articles of Organization as the "Company."
 - 2. The period of its duration is perpetual.
