FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on to-wit: the 26th day of September, 2008, Richard A. Mize, a single man, did execute a certain mortgage on property herein described to MERS, as nominee for Superior Bank, which said mortgage is recorded as Document Number 20081002000388610 in the Office of the Judge of Probate of Shelby County, Alabama.

WHEREAS, on the 15th day of June, 2010, the day on which the foreclosure sale was to be held under the terms of said notice between the legal hours of sale, said foreclosure was duly and properly conducted and Superior Bank did offer for sale and sell at public outcry in front of the Courthouse door in Shelby County, Alabama, the property hereinafter described:


WHEREAS, Marcia St. Louis was the Auctioneer who conducted the said foreclosure sale and was the person conducting the sale for Superior Bank, and Superior Bank, was the best and highest bidder in the amount of One Hundred Seventy Thousand and 00/100 Dollars (\$170,000.00) which sum of money is offered as credit on the indebtedness secured by said mortgage; and said property was thereunto sold to Superior Bank.

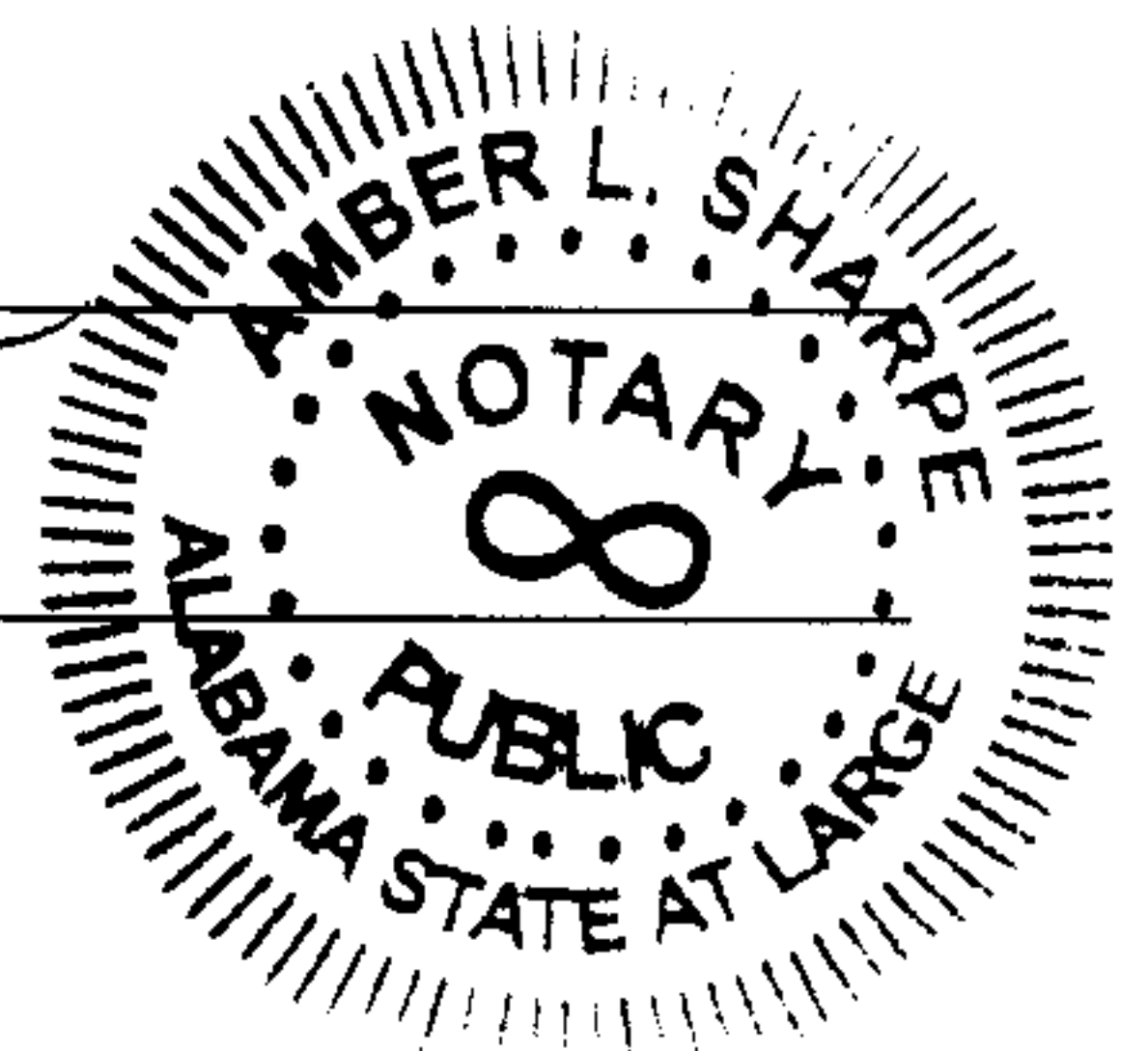
