KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 15th day of May, 2008, Christopher H. Plummer and Linda J. Plummer, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. solely as nominee for Platinum Mortgage, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20080523000211560, said mortgage having subsequently been transferred and assigned to CitiMortgage, Inc., ("Transferee"); and


