FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 28th day of April, 2008, Stephen S. Wilson, an unmarried man, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. solely as nominee for Allied Home Mortgage Capital Corp, an Alabama corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20080508000188710 and modified in Instrument Number 20100121000020790, said mortgage having subsequently been transferred and assigned to CitiMortgage, Inc., ("Transferee"); and
