

Commence at a rebar in place, said point being the Southeast corner of the Northwest ¼ of the Northeast ¼ of Section 5, Township 21 South, Range 1 East, Shelby County, Alabama, thence proceed North 87 degrees 15 minutes 24 seconds West along the south boundary of said ¼ - ¼ section for a distance of 666.57 feet to a rebar in place, said point being the point of beginning.
