

In consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, U.S. Alliance Coosa Pines Corporation now known as Bowater Alabama LLC ("Bowater"), grantor under that certain statutory warranty deed (the "Deed") of timberland property described therein (the "Property") dated February 10, 2000, and recorded with the Office of the Judge of Probate in Shelby County, Alabama, in Inst. #2000-04452, does hereby terminate and release any and all of its timber cutting rights, rights of first offer and other rights relating to the Property as more particularly described in, and to be exercised pursuant to the terms of, that certain Fiber Supply Agreement dated as of February 10, 2000, by and between John Hancock Life Insurance Company, Great Eastern Timber Company LLC, Cahaba Forests, LLC and Hawaii ERS Timberland LLC, as Sellers, and Bowater as Buyer (the "Agreement"), and as further described and evidenced by that certain Memorandum of Supply Agreement and Right of First Offer attached as an exhibit to the Deed.

This Full Release of Bowater's rights under the Agreement is authorized by, and pursuant to, that certain order (the "Order") entered on December 4, 2009, by the United States Bankruptcy Court for the District of Delaware in the chapter 11 cases of Bowater and affiliates (jointly administered under Case No. 09-11296) concerning Bowater's rejection of the Agreement, a certified copy of which is attached hereto.



ORDER APPROVING REJECTION OF CONTRACTS


Pursuant to the Order Pursuant to Sections 105(a) and 365 of the Bankruptcy Code Establishing Expedited Procedures for the Rejection of Executory Contracts and Unexpired Leases entered on June 29, 2009 [Docket No. 556] (the "Expedited Procedures Order"); and it appearing that the Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334; and it appearing that this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2); and it appearing that venue of this proceeding and this matter is proper pursuant to 28 U.S.C. §§ 1408 and 1409; and it appearing that the Debtors have properly filed and served the Notice of Rejection² of the contracts set forth on Attachment 1 hereto (each a "Rejected Contract" and together, the

"Rejected Contracts") in accordance with the Expedited Procedures Order, and that such notice is adequate and no other or further notice need be given; and no timely objections to the Notice of Rejection having been made; and the Court having found and determined that the relief sought is in the best interests of the Debtors, their estates, their creditors and all other parties-in-interest; and after due deliberation and sufficient cause appearing therefor, it is hereby **ORDERED** that:

- 1. The Debtors' rejection of each of the Rejected Contracts is approved.
- 2. Each of the Rejected Contracts is rejected effective as of the corresponding Rejection Date set forth on Attachment 1 hereto.
- 3. Any claim against the Debtors arising from the rejection of a Rejected Contract shall be filed in accordance with the procedures set forth in the Expedited Procedures Order.
- 4. Nothing in this Order shall prevent the Debtors from seeking such other or further remedy that may be available to them with respect to the Rejected Contracts.
- (the "Agreement") dated February 10, 2000, as amended, by and between sellers John Hancock Life Insurance Company ("Hancock"), Great Eastern Timber Company, LLC, Cahaba Forests, LLC ("Cahaba"), and Hawaii ERS Timberland LLC ("Hawaii") and buyer Bowater Alabama LLC as successor to U.S. Alliance Coosa Pines Corporation ("Bowater"), Hancock is hereby authorized on behalf of Bowater to prepare, sign, and record with the appropriate Alabama real estate land records, full releases, substantially in the form attached hereto, of Bowater's timber-cutting rights, rights of first offer and other rights as more particularly described in the Agreement and in the recorded statutory warranty deeds (including the Memoranda of Supply Agreement and Right of First Offer) that are identified in the attached spreadsheet.

- 6. Notwithstanding any provision in the Bankruptcy Rules to the contrary:

 (a) this Order shall be effective immediately and enforceable upon its entry; (b) the Debtors are not subject to any stay in the implementation, enforcement or realization of the relief granted in this Order; and (c) the Debtors are authorized and empowered, and may in their discretion and without further delay, take any action and perform any act necessary to implement and effectuate the terms of this Order.
- 7. This Court shall retain jurisdiction with respect to any matters, claims, rights or disputes arising from or related to the implementation of this Order.
