AN EASEMENT
FOR THE CONSTRUCTION, OPERATION, AND MAINTENANCE

This EASEMENT, executed this 22 day of APR., 2010, for the construction, operation, and maintenance of utilities with appurtenances, by The City of Calera, hereinafter called the OWNER across the property of the LANDOWNER, Cornerstone Corporation LLC., as shown on the attached sketch, is granted by the LANDOWNER to the OWNER for valuable considerations, the receipt and sufficiency of which are acknowledged by the LANDOWNER, for himself, and his heirs, executors, successors, and assigns.

One permanent easement, to go with the land to allow the OWNER, its employees and agents to construct, operate, repair, and maintain the OWNER'S utilities including the right of access by the OWNER, its employees and agents, or officials, and necessary related equipment. Included is the right to uncover the utilities, with the obligation to leave the LANDOWNER'S property in good repair after completion of any repair to the utilities.

Located in the City of Calera, Shelby County, Alabama a 10-foot wide utility easement being 390'± lying west of and parallel to the west right-of-way line of Shelby County Hwy 12 and being in the most eastern portion of said property as shown on the attached sketch.
