KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 11th day of December, 2007, Terrance Brown and Valerie Brown, Husband and Wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for Alethes, LLC, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20071221000573850, said mortgage having subsequently been transferred and assigned to GMAC Mortgage, LLC, ("Transferee"); and
