KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 2nd day of July, 2004, Kimberly W. Hildenbrand and husband, John Hildenbrand, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as a nominee for SIRVA Mortgage, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Inst. No. 20040712000382070, said mortgage having subsequently been transferred and assigned to CitiMortgage, Inc., ("Transferee"); and

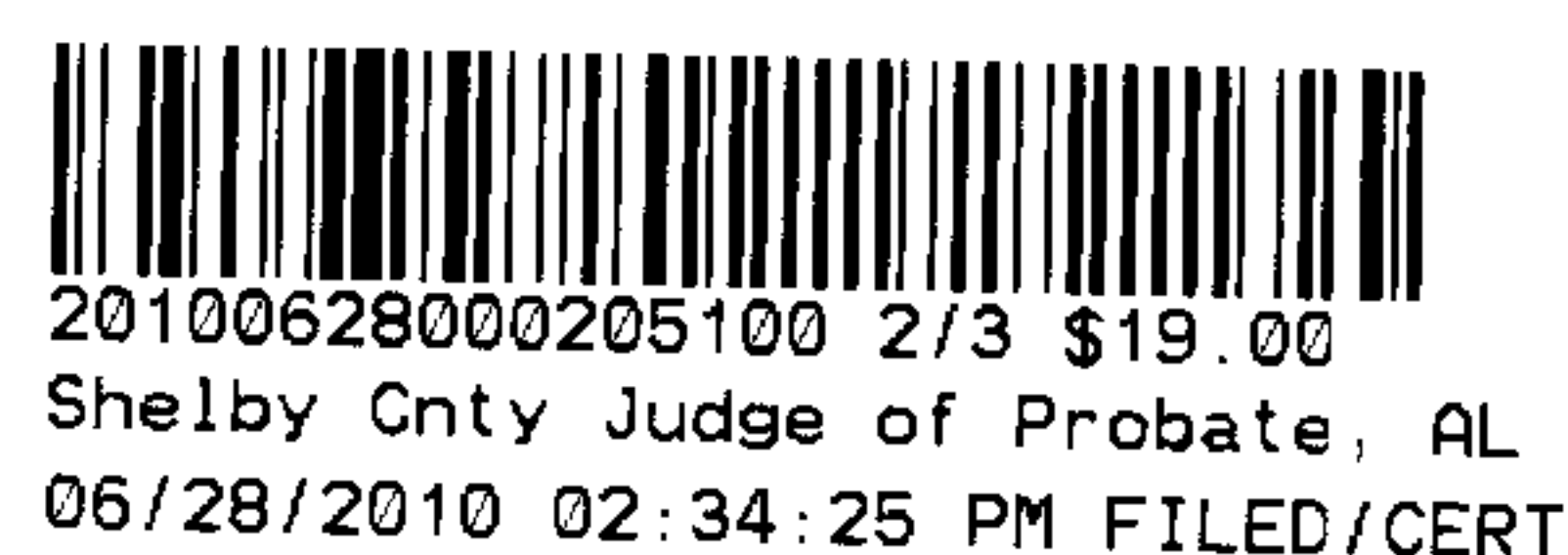
