

# ARTICLES OF INCORPORATION OF

# ALABAMA VETERINARY MANAGEMENT SERVICES, P.C.

TO THE HONORABLE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA:

Pursuant to the provisions of the Revised Alabama Professional Corporation Act, as set forth in Sections 10-4-380, et seq. of the <u>Code of Alabama</u> (1975), as amended from time to time (the "Act"), the undersigned, **Timothy M. Fulmer**, acting as incorporator of a corporation, adopts the following Articles of Incorporation for the corporation:


#### ARTICLE I - NAME

The name of the Corporation is ALABAMA VETERINARY MANAGEMENT SERVICES, P.C.

#### ARTICLE II - PURPOSE

The purposes for which the Corporation is formed are:

- (a) to engage in every phase and aspect of the practice of veterinary medicine and to render such services ancillary thereto in accordance with the Act as amended from time to time; provided, however, the corporation shall not engage in any business which is unrelated to the practice of veterinary medicine, and the corporation shall provide veterinary services only through those individuals licensed to provide such veterinary services; and
- (b) to engage in any and all transactions and activities necessary, appropriate, customary, convenient or incidental to any of the foregoing purposes, and to exercise all powers necessary to, or reasonably connected with the corporation's business described above, which may be legally exercised by professional corporations under the Act.



### ARTICLE III - OFFICE AND AGENT

The location of the initial registered office of the corporation shall be 4506 Lake Valley Drive, Birmingham, Alabama 35244 and the name of the initial registered agent at such address is **Timothy J. Brunner**.

## ARTICLE IV – AUTHORIZED SHARES

The authorized capital stock of the Corporation shall be One Thousand (1,000) shares of common stock having a par value of One and No/100 (\$1.00) Dollar per share.

#### ARTICLE VI – BOARD OF DIRECTORS



The period for the duration of the corporation shall be perpetual.




