

ARTICLES OF INCORPORATION OF GOD'S PEEPS, INC.

A BODY CORPORATE

TO THE HONORABLE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA:

The undersigned, **Joseph P. Schilleci**, **Jr.**, acting as incorporator of a corporation under the Code of Alabama, adopts the following Articles of Incorporation for the corporation:

ARTICLE I – NAME

The name of the corporation shall be **God's Peeps, Inc.**, and the corporation shall be authorized to operate under that name or use any other trade name not now being used by another person, firm or corporation.

ARTICLE II - PURPOSE


