**ARTICLES OF ORGANIZATION

Pursuant to the Alabama Limited Liability Company Act (the "Act"), the undersigned hereby adopt the following Limited Liability Company Articles of Organization:

ARTICLE I

NAME

The name of the limited liability company (the "Company") is: "HOLDING HER MAT, L.L.C."

ARTICLE II


DURATION

The period of duration of the Company shall be perpetual from the date of the recording of these Articles with the Probate Judge of Shelby County, Alabama, unless earlier terminated by agreement of the members or by operation of law.

ARTICLE III

PURPOSES

The Company's purposes are to raise awareness of children's health issues by raising funds for organizations that assist families of children with health issues, and to do everything necessary, proper, advisable or convenient for the accomplishment of such purposes, and to do all other things incidental to such purposes or in connection with such purposes that are not prohibited by law. In extension and not in limitation of the purposes specifically enumerated, the Company is authorized and empowered to engage in any lawful business designed to further the basic purposes of the Company as set forth above.

MANAGEMENT


The Company shall be managed by the members.
