I, TRACY ADKINS HILL, a resident citizen of Shelby County, State of Alabama, being of sound mind and disposing memory, do hereby make, publish and declare this instrument as and for my Last Will and Testament, hereby revoking any and all other wills and codicils thereto made by me.

ITEM ONE: I give, bequeath and devise all of my property of whatever kind and sort the or character, and wherever situated, or which I may own or to which I may be entitled at the time of my death, or to which my estate may become entitled after my death, or over which I may have any power of disposition, including all real estate and financial accounts to my beloved spouse Doyle Reagan Hill. If my spouse should both predecease me then I give, bequeath and devise all of my property of whatever kind or character, and wherever situated, or which I may own or to which I may be entitled at the time of my death, or to which my estate may become entitled after my death, or over which I may have any power of disposition, including all real estate and financial accounts to my children equally to each and their heirs and assigns.

ITEM TWO: I hereby designate my spouse, Doyle Reagan Hill as executor hereunder.

ITEM THREE:

(a) I direct that my executrix shall not be required to give bond or to file an inventory or appraisal of my estate in any Court, and I direct that she shall be free from the control and supervision of any Court.

(b) I hereby vest in my executor full powers of management, control and disposition of my estate, including the power to sell, convey, exchange, encumber, or otherwise dispose of all or any property in my estate in such manner and upon such terms and conditions as my said Executor may approve, including public or private sale, without the order or supervision of any Court. Specifically, I hereby vest in my executor full powers to sell any or all real property of my estate.

ITEM FOUR: It is my will and I desire and hereby direct that my funeral expenses including the cost of a proper grave marker and burial plot, the costs of administering my estate be paid from my estate.

ITEM FIVE: In the event one or more of my children be minors at the time of the death of the survivor of my husband and me, I do hereby designate and appoint as guardian of the person of said minor children, Debbie Wood, who at the time of the filing of the execution of this will is residing in Shelby County, Alabama. I do hereby exempt said guardian from the necessity of giving bond or filing an inventory to any court. It is my intention by the appointment of such guardianship that the guardian shall have the custody of the person of the minor child, being responsible for furnishing a proper home environment and seeing to the education of such minor.

ITEM SIX: My executor shall be authorized to employ as legal counsel Michael A. Hensley, or any firm of which he may be a member, in all legal matters in connection with the administration of my estate and of to pay such counsel reasonable compensation for such services.
