

**ARTICLES OF ORGANIZATION
OF
S G MANAGEMENT, LLC

A LIMITED LIABILITY COMPANY
ORGANIZED UNDER THE LAWS OF ALABAMA**

The undersigned, acting as the organizers of a limited liability company under the Alabama Limited Liability Company Act, hereby adopt the following Articles of Organization for **S G MANAGEMENT, LLC**, a limited liability company (hereinafter called the "Company").

ARTICLE I

NAME

The name of the Limited Liability Company shall be **S G MANAGEMENT, LLC**.

ARTICLE II

DURATION


The Company shall continue in existence until it is dissolved in accordance with the Alabama Limited Liability Company Act or other applicable law.

ARTICLE III

PURPOSES

The Limited Liability Company has been organized for the following purposes:

- (a) To operate a landscaping, maintenance and/or grass cutting business.
- (b) To acquire, hold, lease, sell, convey, and mortgage and otherwise dispose of real estate and its appurtenances and to cultivate, improve and develop the same and contract in reference thereto.
- (c) To borrow money, to issue notes, bonds and to secure the same by deed of trust and mortgage.
- (d) To make loans to corporations or individuals and to secure the same by deed of trust, or any other lawful method.
- (e) To engage in any lawful business.
- (f) Without in any particular limiting the objects and powers of the limited liability corporation, it is hereby expressly declared and provided that the limited liability corporation shall do any and all other acts and things and exercise any and all other powers which a limited liability

company could do and exercise, and which is now or hereafter authorized by law.

ARTICLE VII


RIGHT TO CONTINUE

MANAGEMENT


The limited liability company shall be managed by one or more managers. The name and mailing address of the initial manager, who shall serve as manager until the first annual meeting of




